- **Number of words:** The abstract should not exceed 350 words.
- **Font and spacing:** Calibri 10 pt font and single-spaced.
- **Title:** 130 characters (excluding spaces) and bold.
- **Authors:** Last name only, followed by a space and initials (e.g., Valdés R1,). There is no limit to the number of authors, but the primary author should be distinguished.
- **Affiliations:** Each author should be listed by department, institution, city, and country.
- **Tables, figures or graphs:** Do not include tables, figures, or graphs.
- **Title alignment:** centered.
- **Abstract text alignment:** justified.
- **List of authors alignment:** centered.
- **Author affiliation alignment:** justified.
- **Contact Information:** Presenting author's email address is required; this information should appear below the abstract.
- **Language:** English. **Lecture language:** English
- **Abstract submission deadline:** April 30<sup>th</sup>, 2025
- **Acceptance Deadline:** July 31<sup>st</sup>, 2025
